

# **Pavilion Rules & Regulations**

1. Pavilion will be **closed** to the public for the purpose of judging from 12pm Friday 5<sup>th</sup> May 2023.
2. Pavilion will be closed at **6pm** Saturday afternoon, **all entries will be available for collection at the pavilion front door from 6.30pm. No exhibitor is allowed to remove an item before 6.30pm unless prior arrangement is made with secretary.**
3. Stewards and judges only are allowed in the pavilion during judging.
4. Where the exhibits bear name of the exhibitor in any class in which he or she is an exhibitor the said name must be carefully covered until judging is completed.
5. The decision of the judges is final unless logical reasons are produced to substantiate a protest. In the event of a protest arising, it must be lodged with the committee within an hour of the judging of the event. Such protest will be in writing and accompanied by a fee of \$50 which shall be retained by the society if the protest is found frivolous. Such protests shall be settled by a majority vote of the committee, whose decision is final.
6. No person shall act as a judge over entries in which he/she is an exhibitor.
7. The judges have the power to award the schedule of prizes of the society providing the exhibits are of sufficient merit. The judge may award only 2<sup>nd</sup> prize or withhold a prize altogether when the entries are not of sufficient merit, in which case they shall state the reason on an award paper.
8. For Champion awards, all 1<sup>st</sup> prize winners in relevant classes will be eligible to compete. The 2<sup>nd</sup> prize winners in the class of the exhibit judged Champion shall be eligible to compete for Reserve Champion. No entry fee.
9. All entries to be presented to pavilion along with exhibitor tickets before **12pm Friday 5th May 2023 unless otherwise stated.**
10. Exhibitor tickets will be available from the secretary's office. **Secretary's office will be open from 2.00pm until 5.00pm on Thursday 4<sup>th</sup> May and from 8.00am until 12.00pm Friday 5<sup>th</sup> May 2023,** tickets can also be obtained by emailing or entering through our website via Showday online .
11. Miscellaneous Classes - ie, any other variety/breed/item not specified. In the event of 3 or more items of one kind or type being entered, the stewards will designate an extra class. The judge will then award for this class and then for the remaining items in the miscellaneous class.
12. First prize money will be awarded except where special trophies are given. In which case only the trophy will be awarded.
13. Stewards reserve the right to place entries into a different class if it is found entries have been entered in a wrong class.
14. Judges must follow schedule.
15. **No-one other than Chief Steward of each section is permitted to talk to judge during judging. No-one including Chief Steward is to discuss entries with judge during judging.**
16. The committee will not under any circumstances, hold itself responsible for any loss, mis-delivery or any damage of exhibits in this exhibition.
17. The society will not be responsible for any accident that may occur in the showgrounds. It shall be a condition of entry that all persons shall hold the Society blameless and indemnify it against any legal proceedings arising from accidents.
18. The committee reserves the right of refusing to admit any exhibit to the grounds where there is a reason to suspect that it is diseased or dangerous, or to remove any such exhibit from the grounds.
19. The committee reserves the right to alter or delete from the program.

20. **No exhibitor** will be allowed to remove, or in any way interfere with any article in the pavilion until 6.30pm on the day of the show unless prior arrangement in made with the secretary. **Entries will be handed out at 6.30pm by the stewards.**
21. This society provides First-Aid assistance on the grounds during the show but the responsibility of Ambulance Transport remains with the patient whatever their involvement in the show.
22. No exhibit can compete in more than one class.

**Entry fee for events in the pavilion are \$1.00 unless stated otherwise.**
